The personal data provided by you to the Data Controller are processed electronically and on paper. #### **Data voluntarily furnished by the party**

#### **Navigation datas**

Computer systems and software procedures responsible for the operation of the website [www.hotelroyalegolf.com](http://www.hotelroyalegolf.com) in the course of their normal function acquire certain personal data, whose transmission is implied by the use of Internet communication protocols. Those informations are not collected to associate and identify the data subjects, but, by their nature, could allow the identification of the user through processing, associations and crossings with data held by the Owner and third parties. This category includes: IP addresses, computer domain names accessed by users, URI notation addresses (uniform Resource identifier) of the required resources and their timetables, the method used to submit the request to the server, the size of the file obtained in response, the numeric code indicating the status of the response of the data server (good end, error, etc.) and additional parameters of the operating system and computer environment of the user.
